## 17 **Planning**

# Change of use to store additional Touring Caravans Three Horseshoes 18/02109/FUL

The meeting was suspended to allow applicant and objectors to put their case.

Once the Meeting resumed the Councillors debated the application. Concerns were raised about the incremental nature of the applications on this site, the unsuitability of the proposed storage site and the inadequacy of the tree planting proposals. It was also commented that the business plan is not viable and does not support the project-the income generated is insufficient to warrant the purported expenditure unless there are plans for further development. There are other fairly nearby locations more suitable for storing of caravans-outside the AONB. This is an AONB and that should be taken into account. Furthermore it is not in the spirit of the Applicants previous undertakings to Wheathill Parish Council meeting in public session that there would be no more developments following the previous successful application. On a show of hands 4 Councillors voted to **oppose** the application on the aforementioned grounds with one vote supporting.
